Dear Applicant:

Your application will be considered for either the \$1,000 Worth M. Hudson Scholarship or the \$500 VMDAEC Educational Foundation Scholarship. The Scholarship must be used for your college tuition, books, fees, and/or room and board.

In order to be considered by the Educational Scholarship Foundation Board for one of these scholarships, you will need to comply with the following requirements:

1. Applicant Eligibility:

- You must be entering a post-high school educational institution as a freshman
- You must submit a completed application form including all supporting documents
- Parent/guardian's primary residence must be served by an electric cooperative that is a member of the VA-MD-DE Association of Electric Cooperatives (to review the names of the member cooperatives, go to <http://www.vmdaec.com/MemberCoops.aspx>)

2. Application Packet must include the following supporting documents:

- A copy of the most recent electric cooperative bill for your parent's or legal guardian's primary residence
- A copy of your acceptance letter on letterhead from the post-high school educational institution that you plan to attend
- A notarized copy of your preliminary high school transcript showing your GPA sealed in a separate envelope and initialed across the seal by school administration
- A copy of your Standardized Test Scores (SAT and/or ACT)
- A one page Personal Statement
- Three letters of recommendation from individuals not related to you

3. Optional supporting document:

- Your High School's Annual Profile, if available

Members of the Educational Scholarship Foundation Board will review qualified applications in late April. Scholarship recipients are selected based on a combination of the following weighted criteria: financial need at 40%, academic achievement at 40%, and personal statement at 20%.

If mailed, the application form and all required supporting documents must be included in the same envelope and must be postmarked no later than Monday, April 2, 2012. If the application packet is hand-delivered, it must be received in the VMDAEC Office no later than 4:00 pm on Monday, April 2, 2012. Applications that are postmarked after April 2nd or hand-delivered after 4:00 pm on April 2nd will not be eligible for consideration.
