New Luray Little League Field Opens at Ralph H. Dean Recreation Park

The new baseball field at the Ralph H. Dean Recreation Park in Luray opened recently, hosting an Invitational Tournament of State Champions in the Southeastern Region for girls ages 9 and 10. Events and the tournament were held from July 29 through Aug. 4.

“We are astonished and amazed with the park,” said Wayne Hilliard, vice president of the Luray Little League. “We talked about it last fall, and just couldn’t wait to get to the finished product. I think everyone in Luray is excited about it.”

The new field boasts a large concession area, an enclosed media box, VIP seating, and a huge scoreboard in the outfield — all improvements that came as a result of the community of Luray pulling together.

“All of the contractors have been local, they have worked with the town and the league to give us the best rates possible,” said Town Manager Rick Black. “This has been a quick-moving project for the size of it. Contractors have changed their schedules so that the project could be completed on time. It has taken 90 to 100 days for completion, including the terrible winter we had, when we couldn’t do anything.”

He said that one thing led to another with hosting the tournament and construction of the new facilities.

“We hosted a state tournament for boys last year,” Black said. “A lot of people came, and a lot of people stayed in the area. We’re hoping we can duplicate that for years to come; it’s a real positive economic impact on the town to have the tournament here, and the fringe benefits are, we get to use the ball park for the local kids. I think they’re really excited to have this facility here.”

Hilliard said hosting the tournament is a win-win for everyone.

“There are nothing but positives,” he said. “It provides revenue for the town and county.”

Hilliard said the idea for a tournament came when Luray Little League

folks noticed that Huntington, W.Va., held a tournament for boys every year, but no one held a tournament for girls. After a trip to Little League Headquarters in Williamsport, Pa., the group started putting their thoughts together for the girls’ tournament, which consisted of eight teams from Florida, South Carolina, North Carolina, Georgia, Tennessee, Alabama, Virginia, and West Virginia.

“This year, we’re expecting from 1,000 to 1,500 people, if not more,” Hilliard said. “We are just using the new field for the tournament this year, and we are hoping in a couple of years to expand to 10 or 12 teams.”

The Park, located at 625 6th Street in Luray, is open to the public and anyone can make arrangements to use the field, with applications available online at www.townofluray.com.

“It just goes to show that, working together, it can be done,” Black said. “We are just hoping to keep the momentum going, it’s a continuing project that people can be proud of, and continue to use. I think it will just be great.”
